Dr. Martinez	Dr. Martinez gave an explanation of the process the administrative support team used to create the Health and Safety Plan. There was representation by multiple teachers, SPED coordinators, directors of facilities, and APS in creating the plan.
	FPPCS will begin the 2020-2021 school year instruction with remote learning, and has a proposed hybrid model that will be considered at the end of the first marking period, after taking into consideration the status of the COVID-19 Pandemic. Dr. Martinez suggested extending remote learning until January 4, 2021 which is the end of winter break. The administration will review the status of COVID-19 rates at the end of the marking period to determine whether to move to the hybrid learning plan.
	The Health and Safety Plan addresses the CDC, State and local authorities' guidelines. It includes protocols for anyone located in the school or needing to enter the school. FPPCS is diligently monitoring visitors to the school, and working to communicate with anyone who needs to enter that visitors have the option of distanced communication. The Health and Safety Plan provides resources and materials necessary to identify what FPPCS needs to identify health and safety requirements for staff and teachers.
	FPPCS will use blended funds, consisting of the grant already received, and the grant that was just written and submitted.
	The Health and Safety Pan is interconnected with transportation schedules provided by School District for hybrid learning, which gives FPPCS the opportunity to have a one hour break between high school and lower schools.
