B. First Philadelphia Preparatory Charter School CEO

- a. Ms. Deborah Smit, CEO of FPPCS
 - i. Reviewed and discussed with the Board the May 2021 CEO report, previously disseminated to the Board.
 - ii. Reviewed and shared with the Board the enrollment data, noting that current enrollment was 1870 with the target number being 1880; noted that school is having kids enroll/disenroll due to transient population though 13 kids will be enrolling next week;
 - iii. Reviewed and discussed with the Board the current SPED enrollment:
 - iv. Reviewed current attendance rates with the Board, noting 92% at elementary but 75% at high school; noted that attendance was higher in April and the school is reviewing what motivational programs can be utilized to increase attendance, specifically they are allowing students to determine incentive; recognized that end-of-year always proves to be the most difficult with attendance;
 - v. Indicated to the Board that numerous teachers want to continue teaching through Springboard collaborative;
 - vi. Provided various building safety updates with the Board, including water bottle filling stations had been installed as well as bipolar ionization;
 - vii. Informed the Board of various teacher transition and IT support;
 - viii. Informed the Board that kindergarten returned in April 19th and parents had been informed to keep them apprised of changes; noted no COVID-19 issues thus far;
 - ix. Updated the Board on the Food services program;
 - x. Informed Board of Food service program;
 - xi. Informed the Board that the next grades to return will be 1st and 8th grade in mid-May;

- xii. Informed Board of Teacher Appreciation week was on May 3-May 7, noting teachers had expressed that they did not get this at SDP:
- xiii. Informed Board of School Spirit Fridays, such as dressing in different, fun clothing;
- xiv. Provided the Board on update on college enrollment; nothing 50 students as of today had applied, 46 had been accepted;
- xv. Informed the Board that FPPCS was meeting with students who had less than necessary credits for graduation; but expects seniors to have credits necessary.
- xvi. Board brainstormed ideas to get students more excited about college tours.
- xvii. Informed the Board of graduations in June at Quartett Club
- xviii. Informed Board of Career Week: June 14-18
- xix. Informed Bard of May 27 Spring Musicale, which would be broadcasted on Facebook and website; it would be a a re-play of old concerts.

- 2. Informed the Board there was \$10M cash, with \$691k expenditures.
- 3. Reviewed the Profitis and Loss statement, nothing expenses were \$15M but with \$4M positive in revenue; \$308k more than budgeted; that legal was overbudget; and technology was \$81k but that was just on bills received thus far
- ii. Reviewed and discussed with the Board the March 2021 financials.
 - 1. Noted that the school was ahead of budget;
 - 2. Indicated that bills were getting paid quicker since they are getting received quicker;
 - 3. Reviewed the profits and loss statement
 - a. Noted \$18,721,000 paid as of April, which was \$450k ahead of budget;
 - b. Noted that school was black in all major clases;
 - c. Discussed legal contingencies regarding SPEd;
 - d. Noted that some legal expenses in March were moved and reclassificed on legal contingencies;
