## 6.25 TITLE I PARENT AND FAMILY ENGAGEMENT POLICY

First Philadelphia Preparatory Charter School (FPPCS) is required under Section 1116 of the Every Student Succeeds Act (ESSA) to develop a written Parent and Family Engagement Policy for the LEA.
