B. Memphis Street Academy Charter School CEO

- a. Ms. Naimah Holliday Chief Executive Officer
 - i. Reviewed and discussed with the Board the April 2019 CEO report, previously disseminated to the Board. Discussion included:
 - 1. Current total of 749 students with a budgeted of 760 students;
 - 2. Upcoming loss of CID grant, so Administration is in process of determining where budgetary cuts can be made while retaining strong achievement program;
 - 3. Noted vacancies for current and next year positions;
 - 4. Highlighted that the softball/baseball season is currently underway; and
 - 5. Highlighted Spirit Week for the PSSAs.
- b. Ms. Shavonne McMillan Principal
 - i. Reviewed and discussed with the Board the April 2019 CEO report, previously disseminated to the Board; and
 - ii. Discussed that MSA recently completed that Common Assessment III.

C. American Paradigm Schools CEO

- a. Gerald Santilli President of American Paradigm Schools
 - i. Discussed with the Board a proposed contract due to the necessary repairs on the building. Discussion included:
 - 1. Indicating that the roof and window caulking has asbestos, which requires proper disposal in order to safeguard children;
 - 2. Noting that water in school's basement has been determined by the water department to be unclean and likely from local drainage;
 - 3. Recommended getting support from local councilperson to assist in getting the school appropriate support;
 - 4. Indicated that preliminary costs are approximately \$6.5 Million;
 - 5. Indicated that contractor should begin services on May 7, 2019;

- ii. Indicated that APS is in process of hiring additional staff to meet needs of MSA.
- b. Daniel Saidel, Esq. General Counsel to Memphis Street Academy
 - i. Provided recommendations on how Board should move forward with the contract proposed by Mr. Santilli.
- c. Dr. Margery Covello Chief of Staff at American Paradigm Schools
 - i. Reviewed and discussed with the Board the April 2019 APS report, previously disseminated to the Board; and
 - ii. Indicated that APS is in process of filling vacancies.

D. Business Controller

- a. Michael McLeish of Santilli & Thomson LLC Business Controller
 - i. Reviewed and discussed with the Board the February 2019 Financials report, previously disseminated to the Board. Discussion included:
 - 1. Indicated a projected "break-even" of year budget;
 - 2. Highlighted current cash of \$11.5 Million;
 - 3. Indicated that cash is expected to go down in March where there are three payrolls and other payments; and
 - 4. Indicated a disbursement of \$499,000
 - ii. Discussed 5-year Budget Plan, including:
 - 1. Indicating that the School District of Philadelphia requested MSA spend down its \$11.5 Million cash balance, so \$6.5 million is to be used on the building, as discussed by Mr. Santilli;
 - 2. Recommended that MSA utilize a portion of the fund balance into next year's budget to wean MSA off of the CID grant; and
 - 3. Indicated that he was working with the Administration to make budgetary cuts for next year
 - iii. Answered Board questions.
