B. MEMPHIS STREET ACADEMY CHARTER SCHOOL CEO

- a. Mr. Steven Bilski, CEO
 - **i.** Reviewed and discussed with the Board the CEO board report, previously disseminated to the Board.
 - **ii.** *Presented current enrollment numbers by grade and student demographics.*
 - 1. Compared currently enrollment numbers to last year's data as of the same time.
 - iii. Informed the Board that MSA has 90.53% attendance, which is an improvement on last year's number; presented a breakdown of attendance by grade; and shared attendance incentives, such as students with two or less absences being invited to a free trip, including, Philadelphia Zoo, Camden Aquarium, Movie theater and, if f 95% attendance or better, will be invited to Six Flags;
 - *iv.* Discussed A-TSI 2023-2024 School plan, facilities repairs, PIMS uploads, and Epicenter uploads:
 - 1. In regards to A-TSI, Mr. Bilski has worked with Dr. Gregory McGough, who is a school improvement specialist with IU 13 to develop a strategic plan; and reviewed A-TSI proposed plan with the Board.
 - v. Informed the Board that MSA held a back-to-school BBQ, wherein 100 clear bookbags were distributed, and students could meet their teachers; noted that an article was published in Star News discussing the BBQ; and MSA also did a produce give away during this event and distributed fresh fruit and vegetables to community members;
 - vi. Informed the Board that back-to-school night is 9/14 @ 6 PM;
 - vii. Informed the Board of another produce giveaway on 9/20; and
 - viii. Informed the Board that National Hispanic Heritage Month celebrations are kicking off this week as well.

C. AMERICAN PARADIGM SCHOOLS CEO

- a. Ms. Ashley Redfearn, CEO of APS
 - *i.* Congratulated everyone for starting a new school year under the current circumstances, and for making the new school year possible for students and teachers;
 - *ii.* Informed the Board that APS submitted consolidated applications, strategic plans, evaluations, and professional development for MSA.

- *iii.* Informed the Board that for the Strategic Planning, school data was being used to be flexible and make quick moves;
- *iv.* Informed the Board of the changes to leader/teacher evaluations based on PA law changes;
- v. Shared with the Board the ongoing stairwell door and classroom phone upgrade projects;
- vi. Provided overview of enrollment for four schools with the Board;
- vii. Informed the Board that the coaching team conducted new teacher induction in August, and expressed hope to maintain and support new teachers; and
- viii. Provided an overview of data team's ongoing work to the Board. b. Mr. Scott Kramer, CTO of APS
 - *i.* Discussed Temple Teacher Residency Program resolution with the Board, noting:
 - 1. Students who are working on their masters' degree certification; now includes areas such as special education;
 - 2. A resolution is on the board agenda because APS has a meeting scheduled with Temple to discuss the possibility of moving forward; and
 - 3. Students would have to serve at least one year at the school if they receive their masters' degree.
 - *ii.* Informed the Board of the referral program for non-staff members, noting that if someone refers a certified teacher, they receive a payment after the referred teacher works at the school for six months.
